The Church of Scotland Investors Trust Deposit Fund Restrictions

- 31st August 2023
- Fund Restrictions
 - Each institution authorised and exposure limit agreed
 - Maximum exposure to single institution is £20 million
 - No deposit for more than 18 months
 - £2 million minimum on call
 - £3 million with a maturity less than 1 month
 - No more than £5 million placed 12 to 18 months
 - No more than 60% of the fund with a maturity over 6 months
 - No more than 10% of the fund committed to forward contracts (with prior approval)




The Church of Scotland Investors Trust Deposit Fund

- Total Fund = £101.5 million (as at 31st August 2023)
- Invested with 5 Financial Institutions
 - £26.5 million maturing within 3 months
 - £19.0 million maturing within 4 to 6 months
 - £19.5 million maturing within 6 to 9 months
 - £36.5 million maturing within 9 to 12 months



The Church of Scotland Investors Trust Deposit maturity


Maturity Graph 31st August 2023



Portfolio Amount in Millions (£)




The Church of Scotland Investors Trust Performance Graph
